The **Junior Research Group Knowledge and Technology Transfer** (Group Leader: Dr. Matthias Geissler) calls for applications to a position as

Research Associate / PhD student / Postdoc

(Subject to personal qualification employees are remunerated according to salary group E 13 TV-L)

to be filled **as soon as possible.** This is a fixed-term position until 31.12.2020 with 75% of the fulltime weekly hours (30h/week) for PhD applicants and 97.5% of the fulltime weekly hours (39h/week) for Postdoc applicants. The period of employment is governed Fixed Term Research Contracts Act (Wissenschaftszeitvertragsgesetz - WissZeitVG). Further academic qualification is actively supported.

Tasks: Work on the PEER-UP project (Funding scheme: "Quantitative Research in Higher Education", German Ministry of Education and Research), Teaching in "Knowledge and Technology Transfer" or neighboring fields; Research into "efficiency analysis in higher education with focus on publication-oriented output measures", publication of research articles (in English), participation in international conferences; support in academic selfadministration.

Requirements: University degree in Economics, Business Administration, Information Science or similar; Interest in empirical research with a quantitative focus; analytical skills; fluency in English (German is a plus, but not mandatory); self-reliant working style. For Post-Doc applicants additionally: PhD degree with appropriate focus (e. g., Higher Education Research, Efficiency Analysis, Bibliometrics, Network Analysis,...)

We expect high motivation, very good communication and team work abilities and the willingness to integrate into the PhD structures of the TU Dresden and the faculty (for PhD candidates).

The following criteria are not mandatory but count as a plus: Experience with common statistical software (e. g. STATA, R); Experience in handling large data collections, basics in SQL and programming; some experience in scientific conduct (internships, assistant positions, etc.). For Post-Doc applicants additionally: Experience in publication and teaching.

You will become part of a young and dynamic team with little hierarchy and lots of delight in (empirical) research. We will promote the advancement of your career as best as we can, esp. through our international network.
